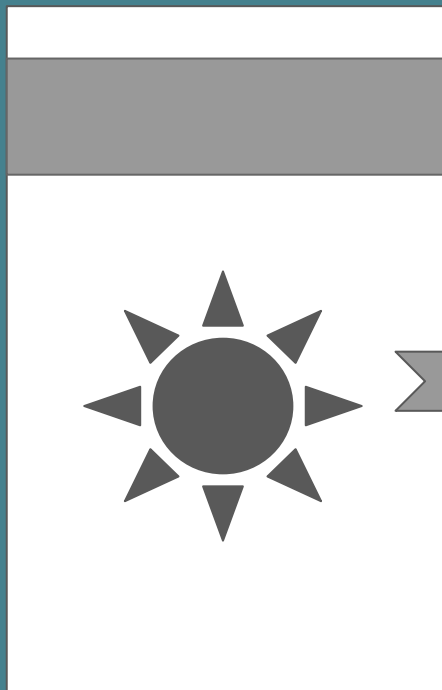

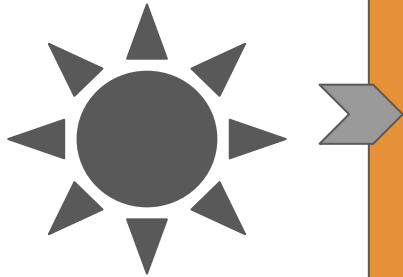

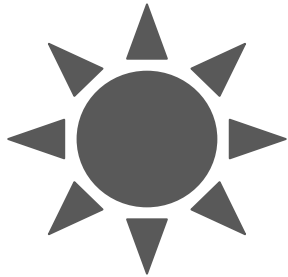
ECO DACA Program

Benefits



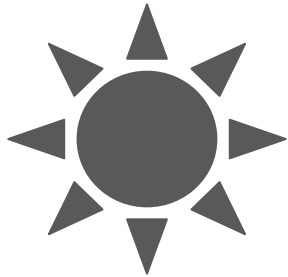
- **Free DACA legal services**
- **Support with filing fees up to \$495**
 - **+ Fee for Advanced Parole up to \$575**
- **Long term immigration counseling support**
- **Interpretation & translation**

Eligibility



- **Oregonian**
- **Income below 200% FPG**
- **Enrolled in ECO**
- **DACA expiring < 120 days**
- **Reside in (not exclusively):**
 - **Region 1: Clatsop, Columbia, Tillamook**
 - **Region 2: Multnomah, Washington, Clackamas**

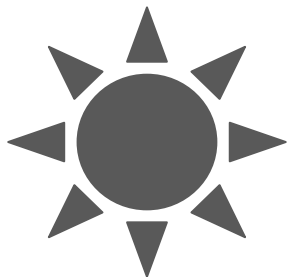
Documentation



- **Your DACA work permit**
- **Your recent DACA approval notice**
- **Your birth certificate**
- **Your Oregon ID, Oregon license, or school ID**
- **Your passport (if available)**
- **Proof of your address**

Additional or different documents may be required to process your application.

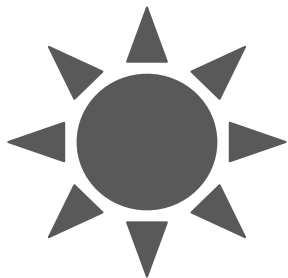

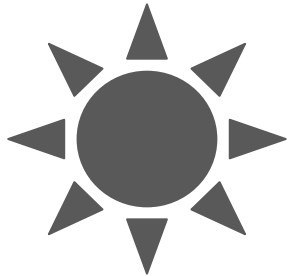


How can I enroll in ECO?

FAQ



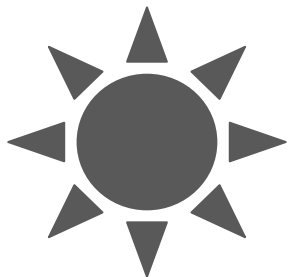
- **What if my DACA is already expired?**
 - You are eligible if your expiration is less than 1 year
- **Is it easy to enroll in ECO?**
 - Yes! It takes one phone call to start.
- **Can I work with my current attorney?**
 - Yes, if your attorney is registered with ECO. Attorney registration is free and easy.
- **What are my long-term immigration options?**
 - We will work with you to analyze your personal situation to find the optimal pathways

- **Is it really free?**
 - Yes! All legal services provided through ECO are **free**.
- **Can I get help with filing fees?**

 - ECO is Oregon's universal representation program. It is part of the Oregon Worker Relief system of support.
